## **PREAMBLE:**

THIS MEMORANDUM OF UNDERSTANDING (MoU) IS MADE AND ENTERED INTO BY  
AND BETWEEN

**TAMIL NADU ASSOCIATION OF NEUROLOGICAL SURGEONS [TANS],**

herein referred to as "PARTIES",

To establish a formal affiliation for the co-ordination of academic, research  
and patient care related activities.

## **1. Purpose:**

The purpose of this MoU is to facilitate collaboration between T## and TANS in the  
areas of academic exchanges, research initiatives, and the enhancement of patient  
care services.

This affiliation aims to leverage the strengths and resources of both associations to  
improve healthcare outcomes in the fields of ##### and neurosurgery.

## **2. Scope of Collaboration:**

### **➤ Academic Exchanges:**

Joint conferences, seminars, and workshops, Exchange of educational materials and resources, Development of joint training programs for members.

### **➤ Research Initiatives:**

Collaborative research projects. Sharing of data and research findings, Joint publication of research papers.

### **➤ Patient Care Services:**

Coordination of patient referrals and consultations. Development of integrated care pathways for conditions requiring both ##### and neurosurgical intervention. Sharing of best practices in patient care management.

## **3. Coordination:**

The Secretaries of T## and TANS shall serve as the primary points of contact for coordinating activities under this MoU. They are responsible for facilitating communication between the parties, organizing joint activities, and ensuring the effective implementation of the MoU.

## **4. Term and Termination:**

This MoU shall be effective from ##.March.2024 and shall remain in effect for one year; either party may terminate this MoU with one month written notice to the other party. The MoU shall be extended with mutual consent after one year.

## **5. Amendments:**

This MoU may be amended at any time by mutual consent of the parties through written modification.

## **6. Confidentiality:**

Both parties agree to maintain the confidentiality of any shared information that is not publicly available.

## **7. Legal and Financial Aspects:**

This MoU is not legally binding and does not entail financial obligations for either party. It serves as a framework for voluntary collaboration.
